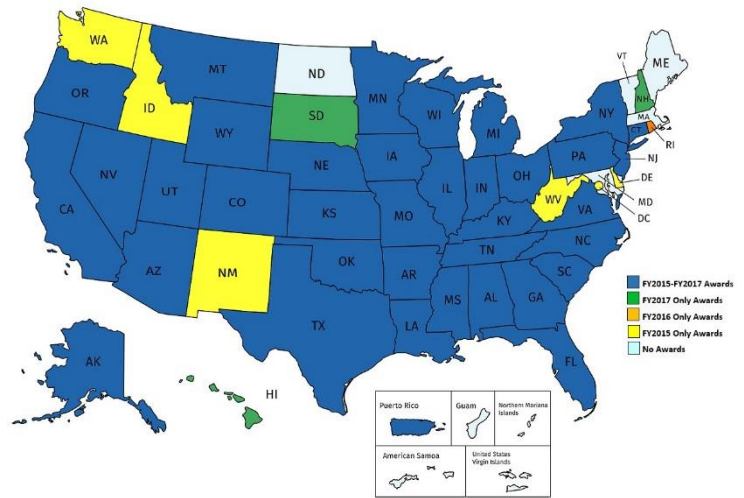


Body-Worn Camera Program

The Department of Justice (DOJ) recognizes body-worn cameras as a law enforcement strategy aimed at improving officer and public safety, reducing crime, adding evidentiary value, and improving trust between police and the citizens they serve. DOJ provides numerous resources to assist state, local, and tribal law enforcement agencies in developing and enhancing their body-worn camera programs. Funding for Body-Worn Camera Pilot Programs

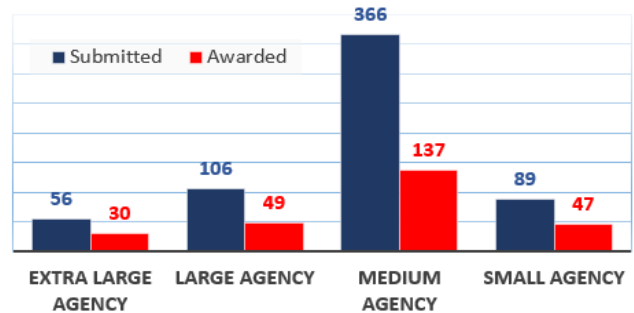
As part of President Trump's commitment to expand funding, training and evidentiary gathering tools to law enforcement agencies and justice communities, the Bureau of Justice Assistance (BJA), part of DOJ's Office of Justice Programs (OJP), has provided over \$58 million to Body-Worn Camera (BWC) Pilot Implementation Programs during the past three years to respond to the immediate needs of local and tribal law enforcement organizations. The BWC Policy and Implementation Program significantly expanded in 2017 with BJA's additional awards to 84 agencies, bringing the three year total to 263 awards.

BJA has processed 630 applications from 48 states, territories, the District of Columbia, and tribal governments. These applicants requested over \$104 million in federal funds and sought the purchase of nearly 105,000 cameras.

The selected training and technical assistance provider, CNA, assists BJA by providing guidance, oversight, training, data collection, research analysis, and performance management to grantees and non-grantees.

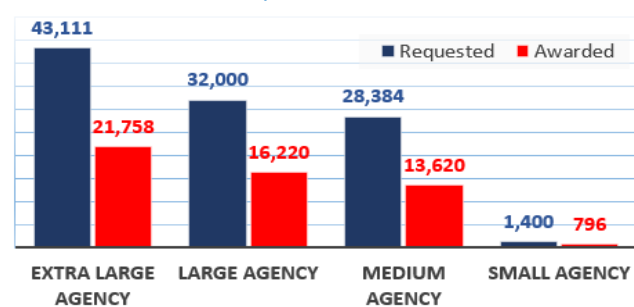
Body-Worn Camera Grant Applications
